This letter is provided in a personal capacity and not on behalf of Sandberg LLP.

I am a Partner and Head of Department with Consulting Engineers, Sandberg LLP. I am also the recent Chairman of the Welding Specialists and Practitioners Management Committee which deals with certification for welding engineers and specialists worldwide and am recent Vice Chairman (and ex Chairman) of the Welding Fabricator Certification Management Committee which covers accreditations to BS EN ISO 3834, BS EN 1090-1 and BS EN ISO 15085 worldwide. These bodies are administered by The Welding Institute in the UK.

Over the years I have sat on a number of other committees for The Welding Institute, The British Institute for Non Destructive Testing and the Chartered Quality Institute. I have also assisted with aspects of the preparation of the National Structural Steelwork Specification and am currently assisting with the 7th Edition.

This involvement has assisted my role within Sandberg LLP to help and guide the structural steelwork industry in support of wider civil engineering, and vice versa. Our work in this field has brought both myself and colleagues into regular contact with Jon Elliot on a number of projects. It has been apparent for a number of years that Jon has been able to bring an unprecedented level of knowledge and understanding of the steelwork industry to civil engineering.
